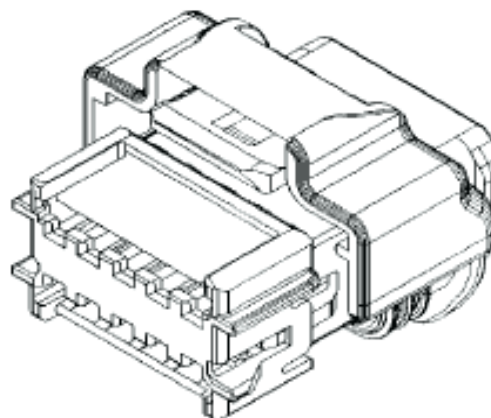

4.2 PACKING INSTRUCTIONS

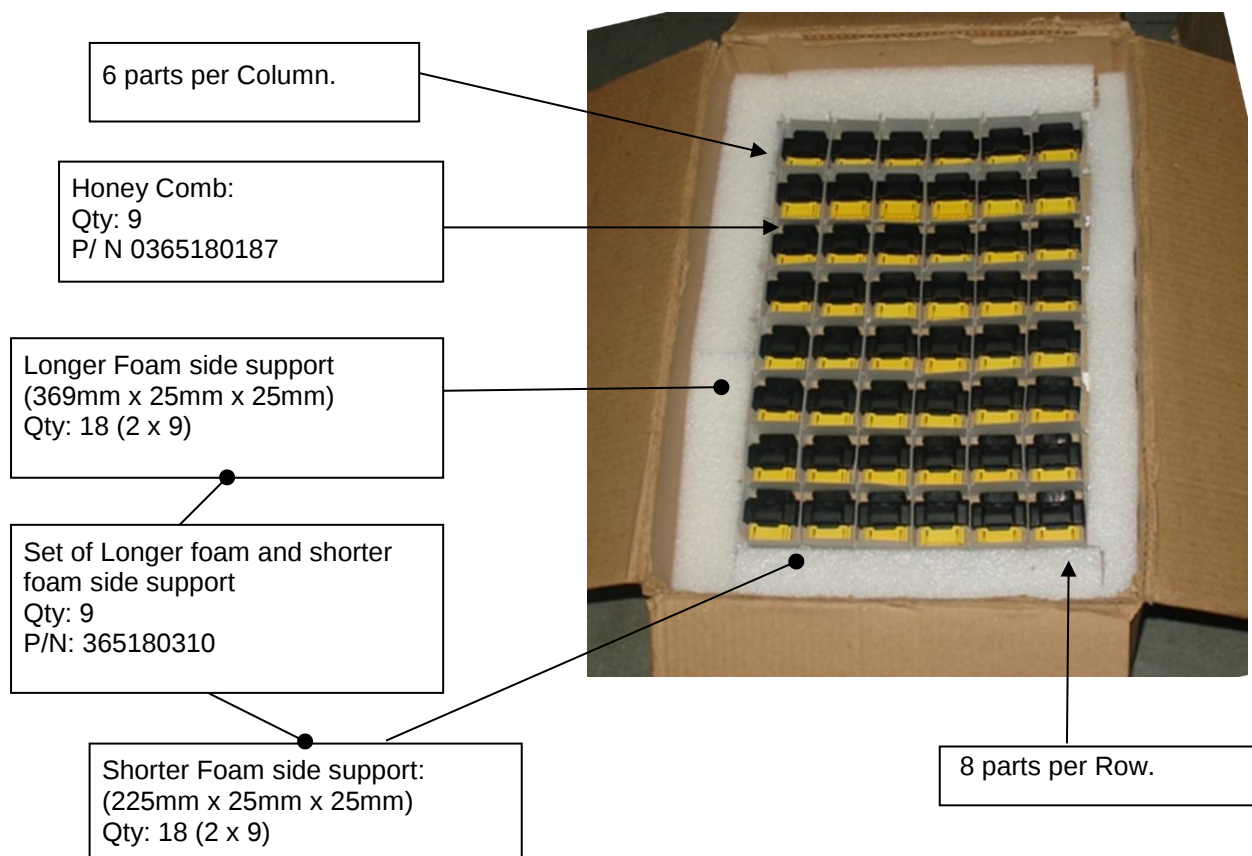
4.2.1 Packaging unit (See FIG 1 & 2)

Assembled connectors are delivered lined up in 9 layers separated from carton interleaf P/N 85040214, each layers are compound of a set of 4 foam side support (P/N 365180310 x1), with Material Number P/N 98788108X in Honey comb P/N 0365180187 placed in a cardboard box Material Number 0967080035.

4.2.2 Lining up layer

→ 48 Parts per layer.

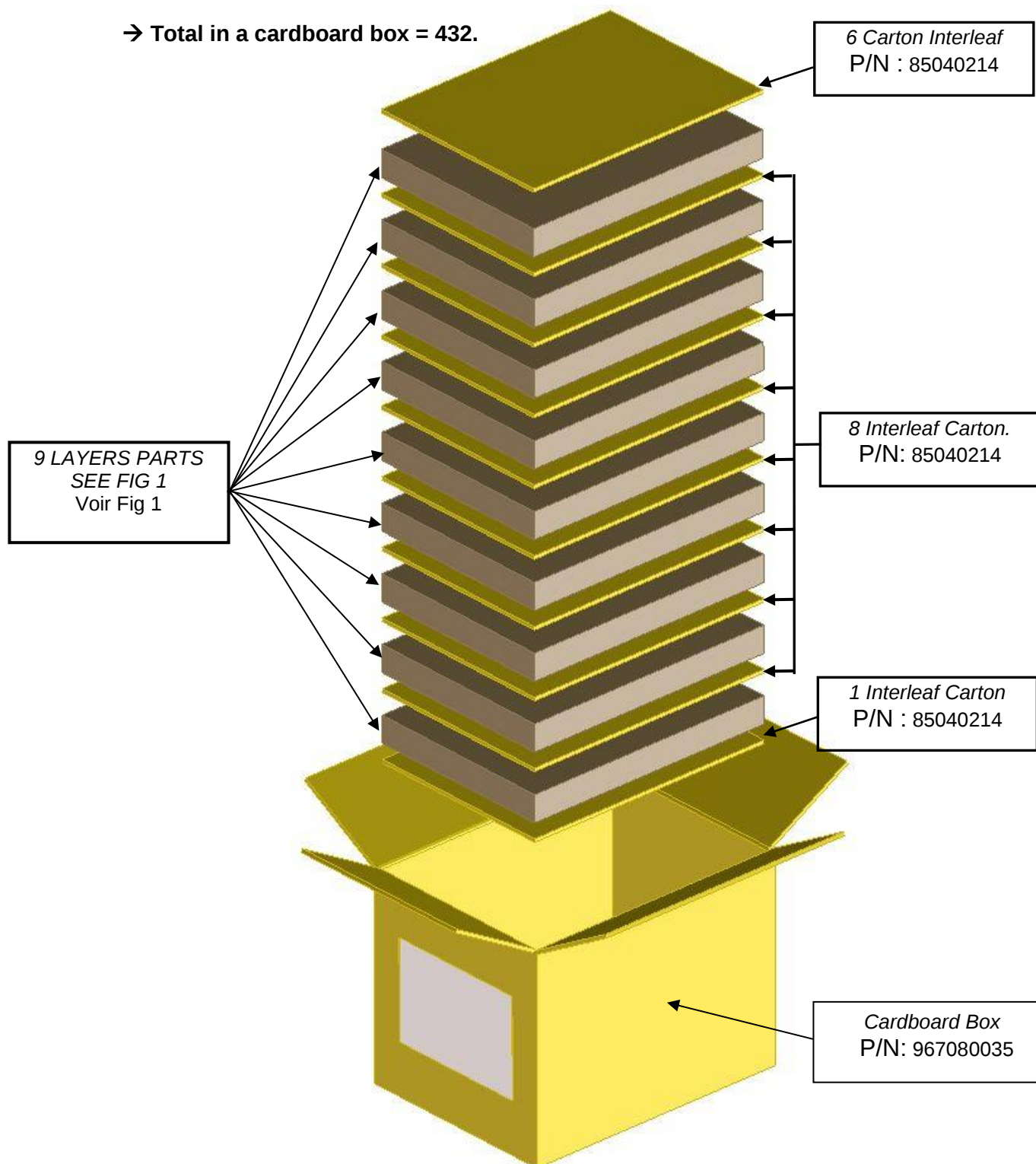

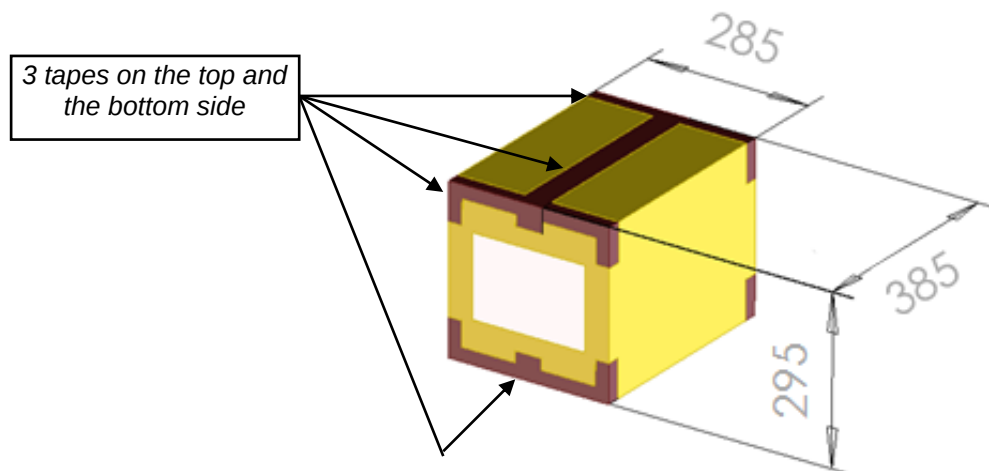

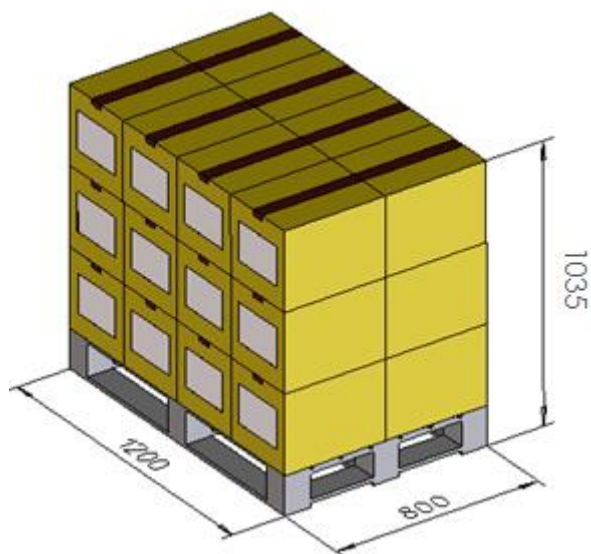

4.2.6 Shipping unit

The shipping unit must respect the standard GALIA rules.

The shipping unit is made of:

- 1 pallet (800 x 1200 mm) material No 0365180038
- 3 layers maximum per pallet
- 8 cardboard boxes per layer



Cardboard boxes must be placed in such a way that the labels must be visible.

No shock or fall will be allowed during the storage until process utilization.

Only 2 pallets can be stacked.

4.2.7 Shipping unit identification

Each shipping unit (pallet) is identified with a label (126 X 76), material number 0884261597, according to GALIA standard and stuck with following information:

- Customer name
- Delivery address
- Delivery note number
- Order number
- Product name
- Quantity
- Supplier
- Label number
- Product description
- MOLEX material number

All label areas must be filled in.

4.3 UNPACKING INSTRUCTIONS

Unpack the products only just before their assembly operation.

Cardboard boxes must be opened carefully.

Do not damage the connectors when cutting adhesive tape on cardboard boxes.
